After practicing a few years as a clinical pharmacist in a regional hospital in northern Québec (Sept-Îles), she went on to do a specialty residency in HIV at Toronto General Hospital / St. Michael's Hospital / University of Toronto (2001-2002). She then joined the Chronic Viral Illness Service of the McGill University Health Center and developed an ambulatory pharmaceutical care service and the Québec Antiretroviral Therapeutic Drug Monitoring

Program. Nancy is also an Associate Clinical Professor at the Faculty of Pharmacy of Université de Montréal where she teaches on viral, parasitic, and fungal infections.
