1.0 Call to Order

The meeting was called to order at 6:30pm.

2.0 CSHP Mission, Core Values, Vision

8.0 Outgoing President's Address

Rita noted that CSHP OB has been very active on various advocacy issues currently facing hospital pharmacists.

Advocacy Updates

- Pharmacy Technician Educational Program Outcomes: CSHP-OB provided input on the on the Pharmacy Technician Program Standards from the hospital pharmacy perspective. Specific feedback was provided on the draft 'Vocational Learning Outcomes' and the 'Elements of Performance for Pharmacy Technician programs' to the Ministry of Colleges and Universities
- Comprehensive Medication Record for Ontarians is a priority project from Ontario Health. Council members Gunther Ha and Sunil Patel will represent CSHP-OB on the project. A project kickoff meeting was held to share the describe the scope of the project and the timelines to be shared at Issues Day.
- A meeting has been held with the Ontario Hospitals Association to collaboratively highlight and advocate for health human resource constraints on hospital pharmacy in both the pharmacist and pharmacy technician workforce.
- Quality Assurance (QA) Programs: Ongoing discussion is occurring with Ontario College of Pharmacists regarding changes to the QA program. A survey and letter were drafted but not yet sent to the College.

Strategic Plan:

• The OB Strategic Plan has now been updated with metrics year to date. The key strategic priorities focus on building a sustainability plan include membership engagement, membership growth and a balanced budget.

Education:





- The Education Committee, under the leadership of Cheyenne Matinnia and Ariane Blanc, are planning for in-person annual OB education conference to be held on November 19th, 2022.
- OB Journal Clubs have been offered as a member benefit with the support of National Delegate Vivian Lee and Membership Chair, Maria Marchese. As a part of the sustainability plan for the Journal Club, the role of the JC Coordinator will be included as part of the Education Committee and will report into Co-Chairs for committee.
- Additional events include:
 - \circ 7 journal clubs
 - o 2 student events
 - 3 primary care webinars
 - 4 chapter education events
 - \circ In-person

Awards:

• The Awards Committee, under the leadership of Co-chairs Amir Imani & Melika Borzagi, have completed the Awards assessment cycle and are hosting the annual Awards program on November 19th in alignment the Fall Education Conference.

Membership:

• The Membership Committee, under the leadership of Maria Marchese and Pauline Bal, have launched the first pilot year of the Mentorship Program.

The Ontario Hospital Pharmacy Management Seminar (OHPMS):

- The OHPMS Committee, under the leadership of Sammu Dhaliwal and Sunil Patel developed a virtual OHPMS in May in lieu of the COVID19 pandemic restrictions.
- The OHPMS Committee is further expanding pharmacy leadership development and is exploring opportunities for a new certificate program development.

Pharmacy Resident Presentations

• The collaboration between CSHP-OB, Pharmacy Residency Forum of Ontario (PRFO) and Ontario Pharmacy Residency Association (OPRA) to offer live and pre-recorded education sessions and/or journal clubs has officially launched. This initiative is intended to provide presentations to the OB members and expand the reach of the pharmacy residents.


9.0 Treasurer's Report




CSHP OB Treasurer Report November 202

Highlights include:

- Ontario Branch currently has an operating budget of approximately \$127,115 (Fiscal 21/22 May 1 2021 April 30, 2022)
- Revenue:
 - Membership fees contributed to 45% of revenue Fiscal 21/22 (was 49% Fiscal 20/21)
 - o Remaining is from event registration/ sponsorship OB education sessions, OHPMS
- FK Travel Grant can no longer be deferred to next year. There is a shifting to calendar year requests so this year there will be an additional request.
- Ongoing work with Exec, Council, Administrative team, Awards, OHPMS and Education committees to review budgets and plan for 2022/23 events and associated budgets.
- Reviewed GIC investments with CSHP National Finance and renewed existing amounts for 180 days and invested an additional \$50,000.
- Co-investment to National (\$21,000 & \$5,300) deferred by 1 year at National's Request. One left for Fiscal 22/23
- Volatility of budget estimates given COVID-19 pandemic moving events to virtual platforms. Avoid non-critical expenses until activities stable.









- Financial Considerations
 - Virtual events to continue in short-term
 - National Re-Investments deferred 1 year (\downarrow reserves)
 - Sponsorship has decreased (\downarrow revenue)
 - FK not replenishing if amount not used
 - o In-Person events starting in 2022 (个expenses)
 - Membership fee increased (national portion only)
 - National is targeting an increase in members (\uparrow revenue?)
- Current Fiscal 2022-23
 - Operating Budget projected:
 - Revenue: \$136K
 - Expenses: \$119K
 - Income: \$17K
 - CSHP OB Reserve as of April 30th 2022 = \$209K

10.0 Update from CSHP National

Jody Ciufo provided an update from National.

- Jody acknowledged the strength shown to keep going through this long pandemic and thanked all hospital pharmacists for their perseverance.
- Jody acknowledged the ON members contributing at the National level:
 - Andrea Beaman National delegate
 - Vivian Lee Past Delegate
 - Megan Riordon Treasurer, CSHP Exec and Board
 - Abby Krupski student delegate

Strat Plan Updates:

Goals:

- Membership: 3500 members in 2023
 - 3761 members confirmed by June 30, 2022 steady increase of 18% since 2020's strategy for sustainability.
 - Increase due to Covid now we have to keep them!
- Greater engagement by members
 - o SM participation, PSN participation, Together regs all increased from previous year.
 - Not great baseline info but steady increase
- Balanced budget planned for 2023
 - Deficits were planned but due to covid, increase gov't grants and decline in travel spending led to surplus over last two years.
 - Membership and sponsor revenues have increased
 - Balanced budgets moving forward.





Priorities:

- Specialization
 - New hospital pharmacy 101 launched in late September with 25 participants already registered. Numbers will climb as program is further promoted. Eight individual modules available in whole or in part.
- Change in name / identity
 - Shifted focus from name to identity inclusion and diversity.
 - Led to development of new Indigenous Pharmacy Professional of Canada (IPPC). Chaired by Jaris Swidrovich and Amy Lamb. Announced at CPhA conference. CSHP facilitated a multilateral meeting including CPHA, Examining Board, NAPRA, technicians, and more.
- Pharmacy technicians as members
 - Increased number of offerings for technicians
 - 32 in 2019 up to 74 in 2022 (12 in ON).

Core Business

- Advocacy
 - o Multilateral outreach
 - Health Canada consultations
- Education
 - Increased number of regs 928 in 2022 and 813 in 2021
 - Hybrid in 2023 March 10 12.
- Member Services
 - o CPRB total applications down 100 from last year
 - Application Roadmap: increase 25% from previous years
 - o Journal: published an early access feature once a month
 - Practice resources:
 - Discharge medication management tool kit
 - Hospital Pharmacy in Canada Survey Report (end of November)
 - New program for hospital and non-for profit supporters cost reduced and benefits increased
- ON membership trends: increased by almost 13% since 2020. Peaked at 968 members in 2022. Working towards a target of 1000 members.
